USEFUL INFORMATION ABOUT THE RENTAL

Penalties, charges and obligations that will invalidate cover if not complied with: 1. Fine management and administration service (FAF): Does NOT include the amount of the fine. In case of fines applied during the rental period, Record go is bound by law to identify the driver and will charge €40 for management and consultation for each fine received. 2. Damage report and claim management, damage and advice procedure service (DAF). In case of damage, the driver must fill in the report and submit it to the rental office. Record go will charge a (DAF) of €50 (included with TCC/P). 3. Special cleaning and smoking: you will be charged €50 (smoking), €95 or €200 (special cleaning), according to the category of cleaning to be carried out, to cover the costs of treatment, special cleaning and the vehicle's withdrawal from our fleet for the duration of the procedure. The smell of smoke will be sufficient proof for the smoking charge, as well as any ash or cigarette butts found inside. Special cleaning charge: €95: mud or dirt inside the car, animal hair, sand, waste (bottles, paper, food waste), stickers. €200: traces of cement, plaster or any other material that implies that the vehicle has been used for construction work, vomit; human or animal faeces, stains on the dashboard, seats, upholstery, trims, seatbelts or any other element within the car's interior; odours and stains from paint, from chemical products, oil or fuel. 4. Replacement of contracted extras and accessories. In case of breakage, loss, misplacement, theft or robbery of an accessory recorded as being present within the vehicle, the contract holder will be liable to pay the amount indicated in point 4 overleaf. 5. An employee will check the vehicle with the lessee upon return and their claims will be taken into account. The customer will be informed of any charge applied according to that provided in the general terms and conditions. They will be provided with documentation to justify the charges. In case of dispute, the lessee may submit their arguments by email to the customer service and claims department. If it is not possible to reach an agreement over the resolution, the lessee may present their claim to the relevant court or consumer authority. 6. Foreign currency payment service (DCC). If a client requests the foreign currency payment service (DCC), the rental charges will be displayed in euros in the "Payment" section of the rental agreement, together with exchange rate information for the selected currency and the conversion fee. 7. Extensions: Record go will not allow rental agreement extensions. Exception: FlexRent rates allow extensions, with the new rental days being applied at the current rate at that moment, regardless of the prices on the day when the booking was made. 8. Authorised driving territory: On the mainland: You may not drive outside of mainland national territory (except France, Portugal, Gibraltar and Andorra, subject to contracting the 'Border crossing' extra). Islands: It is not possible to take the vehicle off the island where it was rented (except between Mallorca, Ibiza and Menorca after taking out the 'Border crossing' extra). Under no circumstances will it be possible to take the vehicle to Formentera; significant sanctions may be imposed on the driver by the local authorities. Non-compliance: penalty of €400. If the vehicle leaves France: €1000 + €0.25/km from the start of the rental, the cover contracted will be deemed void and the contract holder will be responsible for all expenses incurred, including the cost of returning the vehicle.
